About Us

The Maryland Respite Care Coalition is an all-volunteer statewide organization that advocates for respite care services for caregivers across the state.

The Maryland Respite Care Coalition was incorporated in the state of Maryland in June 2000 and remained active in the state as a 501c3 nonprofit organization until approximately 2011. The Coalition re-formed in 2017 and is actively recruiting new members.

The Coalition hosted 14 annual Respite Awareness conferences and was instrumental in supporting legislation that led to the development of the Maryland Caregivers Support Coordinating Council.

What We Do

Most State Respite Coalitions are grassroots membership organizations that consist of volunteers who work together to achieve common goals around affordable, accessible, and quality respite care. In Maryland, our coalition is informal, though there may be new opportunities to make the group more formal.

As the newly re-booted Coalition continues to meet, it will articulate a new mission statement, goals and objectives to guide our work.

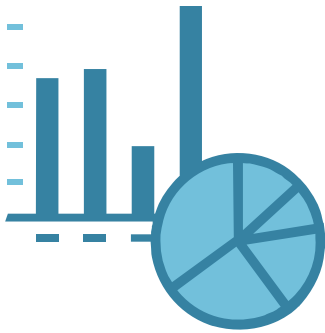

New Respite Resources

In 2016, the Maryland Department of Human Resources and the Maryland Caregivers Support Coordinating Council applied for and was awarded the federal Lifespan Respite Grant from the Administration on Community Living.

The project includes plans to:

- expand access to respite services on an emergency basis,
- offer more training,
- increase the numbers of qualified volunteer respite providers, and
- improve access to services.

Coalition members frequently communicate with the Council to ensure caregiver voices are being heard when it comes to respite care.
